Dear Mr. Gunderson:

Thank you for your e-mail to Secretary Arne Duncan regarding the negotiated rulemaking committee that will be meeting next week and in October to develop proposed regulations to establish standards for programs that prepare students for gainful employment in a recognized occupation. In your e-mail, you ask that the Department abandon its efforts to develop the gainful employment regulations in favor of working with Congress and others to develop new rules through the upcoming reauthorization of the Higher Education Act. In the alternative, you ask that we include additional representatives of private, for-profit institutions on the negotiated rulemaking committee. Your e-mail was forwarded to the Office of Postsecondary Education, and I am pleased to respond.

With respect to the request to abandon the gainful employment negotiated rulemaking process in favor of addressing the issue of gainful employment through the reauthorization of the Higher Education Act, the Department believes that it is constructive to consider new gainful employment regulations even if the upcoming reauthorization of the Higher Education Act addresses this subject area. In fact, moving forward with the regulatory process may inform the reauthorization of the Higher Education Act on this subject.

Further, addressing this issue through the negotiated rulemaking process will ensure that a broad range of interests is considered in the development of new regulations. Specifically, negotiated rulemaking seeks to enhance the regulatory process through the involvement of all parties who will be significantly affected by the topics for which the rules will be developed. Accordingly, section 492(b)(1) of the Higher Education Act requires the Department to choose negotiators from groups representing many different constituencies. The Department selects individuals with demonstrated expertise or experience in the relevant subjects under negotiation, reflecting the diversity of higher education interests and stakeholder groups, including large, small, national, State, and local participants. In addition, the Department selects negotiators with the goal of providing adequate representation for the affected parties while keeping the size of the committee manageable. We believe that the selection of the negotiators for the gainful employment committee achieves this goal and meets the statutory requirements.

The negotiated rulemaking committee's purpose is to develop proposed regulations that reflect a final consensus of the committee. Consensus means that there is no dissent by any member of the negotiating committee. Every member of the committee, therefore, has the ability to block consensus-if he or she is dissatisfied with the proposed regulations developed through the negotiated rulemaking process. Given this, and the statutory requirements, we do not agree that certain groups should have greater representation on the gainful employment committee than others.

We also note that while it is to be expected that some committee members will have interests that differ from other members and that consensus is not always reached, the negotiated rulemaking process is intended to provide stakeholders an opportunity to present alternative ideas, to identify areas where compromises can be reached, and to help inform the agency's views. Thus, we welcome a robust discussion of the draft regulations and anticipate that all committee members will provide their feedback and suggestions for modifying and improving the draft regulations with the goal of reaching consensus.

We are pleased that you chose to nominate several individuals to serve on the gainful employment committee to assist in the development of the proposed regulations. We look forward to working with all members of the committee, including your nominee, Mr. Justin Berkowitz, as well as the other representatives of for-profit institutions who are serving on the committee.

Any individual, including individuals who were not selected as negotiators, may seek to be added as a negotiator at the first meeting of the rulemaking committee. They may also engage in the rulemaking process in several other ways, such as by contacting the individual committee members representing their constituency to express their views and participating in informal working groups on issues between committee meetings. In addition, like any other member of the public, they can submit comments in response to the published notice of proposed rulemaking.

I thank you for your comments, and look forward to your engagement in this process.

The U.S. Chamber of Commerce is the world's largest business federation, representing the interests of more than three million businesses of all sizes, sectors, and regions, as well as state and local chambers and industry associations. For the Gainful Employment Negotiated Rulemaking Committee, the Chamber nominates Cheryl Oldham, vice president of education policy at the U.S. Chamber of Commerce, to represent the interests of the business community and industry, and Vickie Schray, senior vice president of regulatory affairs and public policy at Bridgepoint Education, to represent the for-profit higher education sector.

Oldham oversees education and workforce policy for the Chamber and manages the Education, Employment, and Training Committee (EETC), which sets the policy agenda for the Chamber and its advocacy efforts. EETC directs Chamber policy related to all education and workforce development issues, including workforce development preparation, pre-K through 12 education, postsecondary education, career and technical education, incumbent worker training, and lifelong learning.

Oldham also oversees the programming work for the U.S. Chamber of Commerce Foundation's Education and Workforce Division, which conducts research, develops resources, and promotes policies to ensure that the business community will have an educated and skilled workforce necessary to remain competitive both locally and globally.

Oldham's experience includes six years in senior-level positions with the U.S. Department of Education, including executive director of the secretary's Commission on the Future of Higher Education, chief of staff to the under secretary, and acting assistant secretary for postsecondary education. At the Department, she was highly involved in negotiated rulemaking and therefore understands the process and importance of working collaboratively.

Schray is a member of the executive leadership team of Bridgepoint Education, a publicly traded corporation that is a corporate member of the U.S. Chamber. She is a visible and active

member representing her company as a member of the Chamber's EETC and the U.S. Chamber of Commerce Foundation's Advisory Board on Education and Workforce Development.

In her position at Bridgepoint, Schray is responsible for identifying, influencing, and managing federal and state regulations and public policy as they affect Bridgepoint, Ashford University, and University of the Rockies. In addition, she oversees and provides leadership for institutional compliance programs to ensure fulfillment of federal and state higher education laws and regulations. She has been actively involved in all aspects of implementing the program integrity regulations.

Schray has a long history of working with and on-behalf of the for-profit industry and has demonstrated her ability to go beyond the interests of her own institutions and represent the broader sector. She is a member of the Association of Private Sector Colleges and Universities, serving on a number of committees and presenting at association meetings.

Schray has an extensive background in higher education policy and federal compliance issues. Prior to her employment with Bridgepoint Education, she worked for the U.S. Department of Education and occupied a number of leadership and advisory positions with the secretary and under secretary of education. Schray served as a senior policy analyst in the Office of the Under Secretary and as the acting deputy assistant secretary in the Office of Postsecondary Education. During the Clinton administration, she was responsible for leading the creation of a performance accountability system for all states and institutions under the Carl D. Perkins Act which required building consensus among a diverse set of stakeholders.

At the U.S. Department of Education, Schray assisted in all aspects of negotiated rulemaking and served as the lead federal negotiator representing the federal government on a negotiated rulemaking panel.

Both Oldham and Schray understand the importance of working in good faith as members of a negotiated rulemaking committee to develop and reach consensus on proposed regulations that protect both the taxpayer investment in higher education and ensure student access and success. The Chamber has complete confidence that if selected as negotiators, Oldham and Schray will come to the table in good faith and with every intent to move toward consensus.

Secretary Duncan:

The U.S. Chamber of Commerce is deeply troubled that neither of its nominations to the Gainful Employment Negotiated Rulemaking Committee with extensive experience with issues important to the broad business community was selected to serve, and we urge you to reconsider these nominations. While the Rulemaking Committee does include a member of the U.S. Chamber with expertise in veterans employment issues, it does not have sufficient representation from industry to substantively add to the rulemaking process. The U.S. Chamber believes the Committee must not move forward with such a significant gap in representation. The Committee should be inclusive of a diversity of stakeholders necessary to achieve the objectives set forth by the rulemaking process. While we understand that you selected some participants for the panel with backgrounds in the private sector, you appointed no one that truly represents the employer community. This oversight is significant, and therefore the Chamber respectfully requests your reconsideration of our nominations.

The U.S. Chamber believes very strongly in higher education reform and has worked extensively on issues impacting access and affordability, as well as transparency and accountability. The U.S. Chamber represents the interests of more than three million businesses of all sizes, sectors, and regions, as well as state and local chambers and industry associations. The issues to be addressed through the Committee are critically important to our members and we are very interested in taking part in the process and contributing to the discussion.



Dear Ms. Macias:

This letter is in response to the U.S. Department of Education's request for nominees to participate in the upcoming negotiated rulemaking sessions to be conducted later this year. 78 Fed. Reg. 35,179. We believe this proposed negotiated rulemaking process is misguided and at odds with the recent judicial decision vacating the Department's previous attempt to adopt gainful employment regulations, and with the broader ongoing legislative efforts affecting higher education.

Accordingly, on June 3, 2013, the Association of Private Sector Colleges and Universities (APSCU), on behalf of its member institutions that educate over four million students each year in over 200 occupational fields, asked the Department to postpone convening negotiated rulemaking until Congress acts on the reauthorization of the Higher Education Act, an effort that is currently underway. A copy of that June 3 statement is attached. Similarly, on April 18, 2013 a bipartisan group of Members of the House of Representatives sent to Secretary Duncan a letter asking that the Department abandon its regulatory effort in this area in favor of more comprehensive legislative action.

Unfortunately, the Department has ignored these requests and has chosen to proceed with this flawed regulatory process. Although we continue to have fundamental concerns with the process—and reserve all rights APSCU and its members have to object to that process—we are nonetheless responding to the Department's request for proposed nominations.

APSCU on behalf of its member institutions, which are licensed by the state in which they are located and accredited by accrediting agencies recognized by the U.S. Department of Education, submits the nominations listed below for inclusion on the negotiated rulemaking committee.

Our member institutions include large, publicly held college systems; small multi-campus institutions; and family owned single-campus schools. APSCU members offer programs ranging from short-term career-specific certificate and diploma programs to associate and bachelor's degrees, master's degree, doctoral, and professional degree programs in more than 200 fields.

These institutions operate on a "traditional" semester basis; year-round rolling starts; clock hours; and virtually every schedule in between. Additionally, our representation includes brickand-mortar institutions, online colleges, and hybrid programs.

We strongly believe our institutions have been underrepresented at past negotiated rulemaking sessions, including those during which the gainful employment regulations were first considered. That flawed process resulted in regulations that were vacated by the United States District Court for the District of Columbia as being arbitrary and capricious and in excess of the Department's statutory authority. To the extent the Department does not address our concerns with this negotiated rulemaking, we believe the result will be another flawed rulemaking process and another set of legally deficient final regulations.

For purposes of discussing gainful employment, it is our institutions that are most directly impacted as nearly all our programs are subject to the requirement that "programs prepare students for gainful employment in a recognized occupation." For all other higher education institutions such as public and nonprofit schools, only a subset of programs is covered. Institutions where virtually all programs are subject to the rule will undoubtedly be affected to a much greater extent than institutions with only a handful of programs subject to the regulation. Nevertheless, the Department has reserved slots for representatives from four-year public institutions of higher education, two-year public institutions of higher education, and private, non-profit institutions of higher education, while allocating only a single slot to forprofit schools. The greater impact that our students and schools will face under this proposed regulatory regime clearly warrants increased representation of our interests in the upcoming negotiations.

APSCU believes that slots on the negotiated rulemaking committee reserved for representatives of private sector colleges and universities should be given to someone from an APSCU member institution. Of course, other associations count for-profit institutions among their members, but unlike APSCU, they also represent other interests and thus do not always speak on our behalf and, in many instances, may ignore issues of great importance to our institutions. We believe representatives from our institutions should be given representation on the negotiated rulemaking committee to speak for themselves and the students they serve.

Based on the views expressed above, we believe the nominees submitted by APSCU will represent every constituency of the for-profit sector of higher education and the students they serve. We have listed two outstanding nominees in alphabetical order for each category and each nominee has agreed to attend all negotiated rulemaking sessions, as well as to participate in any needed working groups or conference calls held outside of the regularly scheduled sessions.

Constituency: Private, For-profit Institutions of Higher Education

Issues faced by for-profit institutions can be broken down into several special constituencies based on the manner in which institutions offer educational programs, the duration of those programs of study, and the students served by those institutions. Just as public two-year institutions have different viewpoints than their four-year counterparts, so do for-profit institutions. In that regard, we respectfully nominate the following persons to represent constituencies within the for-profit educational community:


